Charles River Watershed Internships - The Charles River Watershed Association (CRWA) is seeking Watershed Science Interns and Charles River Cleanup Assistant Interns for a variety of field science and watershed management tasks for the spring semester of 2018. Areas of focus will differ depending on the intern's skills and interest, but may include support for field science projects, the annual Charles River Earth Day Cleanup, volunteer engagement, invasive plant management and removal, data management and analysis, and environmental advocacy. Internship schedules are flexible but require a commitment of at least 16 hours per week. Though internships are unpaid, college credit may be obtained. Grants

The Last Green Valley, Inc. (TLGV), a unique region encompassing 35 towns in Connecticut and Massachusetts, has awarded \$15,000 in grants to six local organizations to preserve, protect, interpret, promote or market historic and cultural resources. Since TLGV began awarding historic and cultural grants in 2003, more than \$1 million has been disseminated to local non-profits and towns in the National Heritage Corridor.

Furthermore, TLGV is proud to announce that it has successfully partnered with 19 organizations to bring \$6.1 million in new federal dollars to the region for healthy woods and forest land conservation. Most of the funds will go directly to landowners for bird/wildlife habitat assessments and forest management plans, good forest conservation practices, and easements for permanent woodlands protection. The funding was awarded by the USDA Natural Resources Conservation Service after a very competitive process, and underscores the importance of our southern New England forests to not only the region but the nation. Dam Removal and Sediment Management: Mill River Field Tour

Our 2017 Summer Meeting featured a tour of dam removal sites along the Wild and Scenic Mill River in Taunton led by **Beth Lambert, Aquatic Habitat Restoration Program Manager** at the **Massachusetts Division of Ecological Restoration**. Beth has been managing the projects and shared her abundant hands-on knowledge.

Beth's co-pilot on the tour was **Candice Constantine**, **Fluvial Geomorphologist** with **Interfluve**. Interfluve has worked on over 100 dam removal projects across the country, including the initial feasibility analysis, design, construction oversight and post-project monitoring. The local office has been involved in the removal of three of the centuries-old dams on the Mill River.

The day began at the Holiday Inn, where Beth made a presentation that included soup-to-nuts guidance on sediment management. Attendees then formed car-pools and caravanned around the tour route. Throughout the day, Beth provided background information about the Mill River Restoration Project as a whole for context, but she and Candice focused on the removal of the dams on the tour.






2017 EROSION & SEDIMENT CONTROL FIELD DAYS

These Field Days are a collaborative effort between the private and public sectors to share information and promote a better understanding of the latest tools available to protect soil and water resources. An array of options, both for controlling sediment and for designing & installing more effective long-term erosion control solutions, were on full display at the eight field stations spread out at URI's East Farm. Our goal was to provide information that was immediately useful to all who attended.



Attendees spent approximately 30 minutes at each of 8 outdoor demonstration sites while industry experts provided detailed guidance and shared tips for selection, design, specification and installation.
